2010 COMPETITION GENERAL RULES

1st prize - \$300 **2nd prize - \$200** **3rd prize - \$100**
1st round - Friday, August 14, 7pm **2nd round – Saturday, August 15, 7pm**
Semi-finals – Friday, August 20, 7pm **Finale – Saturday, August 21, 7pm**

- 1) This competition is open to all single, doubles & groups up to six dancers.
- 2) Participants must have parental consent if under 18 years old.
- 3) Finalists and final prize winners will be chosen by a panel of judges selected by the Montgomery County Agricultural Fair (MCAF). The judges' decisions are final.
- 4) Contestants are competing for the following cash prizes: 1st place \$300, 2nd place \$200, 3rd place \$100. Winners will also receive medals: 1st Gold, 2nd Silver, 3rd Bronze.
- 5) All Participants will receive two free admission passes with free parking to the Montgomery County Agricultural competition.
- 6) A total of 40 contestants (20 each day) will compete on Friday, August 13th and Saturday August 14th. 20 will advance to semi-finals on Friday, August 20th. 10 contestants will be chosen to compete in finals on Saturday, August 21st.
- 7) Contestants will be signed up on a first come first serve basis. Once competition is full, no other applicants can be accepted.
- 8) Professional dancers are not eligible to enter.
- 9) MCAF reserves the right to modify or adapt the rules as needed.

Performance Rules

- Each dancer will perform 1 dance on contest night. Performance cannot be longer than 2 minutes.
- Music must be provided by contestant.
- Performance order will be determined by event organizers. Performers must report to community stage in the racing park area at **6pm** to hear their name called for early backstage access.
- No swearing or inappropriate behavior (this is grounds for immediate disqualification).
- Judges will evaluate contestants on the flowing criteria: Performance, Presentation & Audience Reaction.
- Judges reserve the right to disqualify any contestant whose performance or dress attire is inappropriate or does not meet family entertainment standards. No vulgar style of dancing is permitted.
- All participants and their families release the MCAF and it's agents from any liability resulting from their performance and attendance at this event.
- All Contestants give the MCAF the unrestricted authorization to use their name, photo, voice recordings, video recordings, entry materials or likeness in promotional materials without further compensation.
- First place winners may not compete the following year.
- Contestants may not perform the same dance during the elimination rounds in the finals.
